# District 33 Business Meeting Minutes, March 13, 2016

# Committee Reports:

## **DCM** – Tom Anderson

-Tom has been visiting groups.

-Lauren and Tom attended the Winter Committee Meeting.

-Financial data for GSO are disturbing; It is running at a \$500,000 loss.

-GSRs should talk with groups about topics for the Area Assembly. Please refer to attached Winter Committee Meeting Summary.

-Tom and Lauren were placed on a committee to consider redistricting the state. Some districts don't have representation at the area level. A reconfiguration might allow these districts representation. -Regarding the Southern States Area Assembly, our area did not get a bid but will continue to try again for 2019.

-There are three pre-conferences to be held in the state. GSRs are strongly encouraged to attend to give input to our delegate before she goes to New York.

-Flyers go out for the Central Pre-Conference in Kannapolis, NC (Attached).

-It is this district's tradition to support the Central Preconference with a \$75 check.

-Everyone else in the Central Area has hosted this pre-conference twice, and we have not done so. We should consider hosting it. We need a venue (church etc.) with rooms for up to 5 breakout sessions.

# Alt. DCM – Lauren Cioe

-Lauren needs accurate contact information to update the area registrar's list.

-Lauren explains the mock conference at the Winter Committee Meeting to get ready for the conference. Tom and Lauren were put on the literature committee.

-They reviewed a progress report on the revision of several pamphlets including "AA for Women," "Gay and Lesbian Alcoholic," and "Young People in AA." They want to add information about the YPAAs. There is a new pamphlet: "AA for the Alcoholic with Mental Health Issues and Those that Sponsor Them." Most controversially, there was a request to create a plain-language version of the Basic Text. There is special concern for people who work with those for whom English is a second language. Many think we might let an outside organization like Hazelden do that if they think it's a viable option. -As a brainstorming exercise, Lauren and Tom were also asked to think about the following: improving GSO's internal/external communication, increasing revenue, reducing expenses, and altering structure.

# Telephone Answering Service—Anne A

-Anne is getting emails notifying her that our telephone answering service has not been receiving any messages.

-Those leaving correctional facilities may want to leave messages asking to receive contact from an AA member.

-Pam indicates that contact activity reports come with the bill.

-Anne called to test the service and felt the operator was very professional.

## **Corrections** – Rick Holopainen

-Rick just got back from the 28<sup>th</sup> annual Freedom from Bondage Corrections Conference in Aberdeen.
-Rick spent (\$235) on pocket-sized copies of the Basic Text for Alamance County because they were out.
-Rick and Angel S. asked everybody for literature, and many people contributed. A Charlotte group collected over \$500 for a correctional facility that closed down and gave it to us.
-Rick is going to put out collections cans at AA meetings in our district.

-Rick is in contact with Lieutenant Lindley in Chatham County.

-Angel was on a panel on how to approach correctional officials.

-Based on a newly enforced Justice Reinvestment Act, people are being sent to jail instead of prison for DWIs. Someone is serving a four-year sentence at a Jail. We need to help create programs for jails. -May 31 there may be a correctional orientation for Orange County.

-Rick feels he needs to try to keep a supply of donated material, because he often becomes aware of facilities that need literature.

-A new video is being produced to display in correctional facilities.

-Rick urges attendees to ask their groups for literature donations for corrections.
