-Tom has continued to do work for the redistricting subcommittee and has obtained a volunteer pass to visit Orange County Correctional.

- -Lauren talked with Ed who talked with Southern Voices. Jason told him we are on a month-to-month contract with them, and forwarding the calls should be no problem.
- -She attended a service workshop at Basics in Durham—walked through how a homegroup comes up with an idea and how that moves up through higher levels of service.
- -Lauren has continued to update the group contact list.

Corrections - Rick Holopainen

- -For the month, a total of 5 books were donated for a value of \$9 and \$400.61 in cash, for a total value of \$409.61. Our yearly totals are 787 books, at a value of \$2,5088.48, and \$2,645.49 cash, for a total of \$5,233.97.
- -His spreadsheet will be included with the financial reports.
- -The prison did suspend all passes for the weekend due to the storm.

Treasurer's Report - Pam Clarke

- -We had a very good month, with \$1312.71 in contributions; as of the end of September, we were \$1976.27 over our prudent reserve. This means we have \$4900 in the bank, right now. But if you look at the YTD budget vs the actual, many officers haven't spent their budgets yet.
- -We have passed 75 percent of calendar days, collected 85 percent of expected contributions, and spent 57.6 percent of expenses.
- -Pam is seeking suggestions for how to budget for next year given our uncertainty about the telephone answering service.
- -Along with some donations she's received, Anne has \$50 extra for Rick (budget increase).

- -We should consider increasing corrections' budget because corrections has been so active.
- -We shouldn't do away with the other budgets because those committee chairs have been variously active in different years.
- -It is noted that when chairs come to this committee and ask for money, they are often approved.
- -We should introduce a separate line item into the budget for income and expenses just for corrections.
- -We don't always send money up right away, but, at the end of the year, we should not hold "extra" money aside, just in case.
- -It may not be prudent for us to base our budget on exactly what Rick is bringing in/spending.
- -Rick notes there is animosity from some of the groups toward the district. If we merge our funds, he thinks he may lose some contributions.
- -He keeps his inventory down to four books: the Big Book, the Twelve and Twelve, Inmate to

Inmate, and Dailey Reflections.

- -It is pointed out that we should contact Primary Purpose group in Southern Pines and their DCM, to ask them how they budget the corrections money.
- -Anne will put a line item under contributions and expenditures for corrections.

Old Business

- -The area 51 redistricting subcommittee proposal's effects on District 33—we would lose Caswell County.
- -If you have any suggestions or comments, download and submit the suggestion form on the Area 51 website.
- -We will be hosting the central pre-conference April 8, 2017.
- -Jennie P has agreed to chair the subcommittee we have and will be soliciting help within the district.
- -We have a general schedule and a venue. (They will provide cleanup.) We need to get information out to people, and we should talk about what kind of food we're going to have.

- -Lauren: did we hear back from the Triangle Intergroup as to whether we will be accepted? They won't meet until November; District 32 needs to vote on this as well.
- -It's been a while since we've updated our quadfold. Some groups have changed. Anne is aware of a facility that leads 3 or 4 meetings a week that is not on our unified schedule.
- -Leighton suggests sending out an email right away asking for GSR input about new meetings.
- -Lauren gave us three months, last time.
- -The original intent was for the quadfolds to be distributed by CPCPI to professional institutions.
- -They are under the CPCPI budget.
- -It is noted we should be able give out meeting schedules.
- -The old quadfolds could be given out to inmates.
- -Corrections officials are familiar with the quadfolds.
- -Each committee chair has the responsibility to support their work.
